MARKUS DAUSS

University of Bonn

Professor of architectural history and theory at the University of Bonn. Previously, he held guest and interim professorships in Heidelberg, Augsburg, Berlin, and Frankfurt. He earned his doctorate at the École Pratique des Hautes Études in Paris and the Technical University of Dresden with a dissertation on public buildings in Paris and Berlin. His habilitation thesis (Goethe University Frankfurt) reconstructs the history of the metaphor of architecture as writing. His further research focuses include comparative studies of historicism, the history of monuments, infrastructure and mobility, 19th-century painting, and, more recently, ruins and their representations.

Professor of art history, specializing in the history of architecture and urban transformations from the turn of the 19th and 20th centuries and the interwar period, with particular attention to the socio-cultural context, as discussed, for example, in the publications *Eine Stadt zum Leben. Städtebau und Wohnungsreform in Posen in der ersten Hälfte des 20. Jahrhunderts* (Oldenburg 2018) and *Mieszkanie w mieście. Poznań w kontekście europejskich reform mieszkaniowo-urbanistycznych* (Poznań 2018). She participates in the Dissonant Heritage project within the framework of the Urban Agenda for the EU, is a member of the Committee for the Protection of Urban Heritage of PKN ICOMOS, and serves on the Scientific Council of the Polish-German Working Group on Art History and Heritage Conservation / Deutsch-Polnischer Arbeitskreis für Kunstgeschichte und Denkmalpflege. Her current research focuses on the architecture and landscape transformations in the Third Reich and their interpretative perspectives, as well as on the connections between the architecture of Poznań and Strasbourg in the 19th and 20th centuries.
